

EMF ADVISORY UNIT RADIO FREQUENCY ASSESSMENT

VF 46754, O2 43567 St John the Evangelist

Calculations are undertaken to estimate the highest possible radio frequency fields and it is assumed that all channels are transmitting at full power, 24 hours a day. This is a highly unlikely set of circumstances, so in reality, day-to-day measurements will be much lower. It is also assumed that there is no obstruction to the signal by way of structural materials so **levels inside buildings are typically reduced further by a factor of ten**. This information was produced using Telstra Cumulative EMF Assessment Software (RF-Map version) based on the Mobile Base Station Field Intensity Plotter (MBSFIP) Software.

Calculations demonstrated that

- 1. The European Union's recommendation for public exposure to RF fields is based on guidelines established by the International Commission on Non-Ionising Radiation Protection (ICNIRP). The recommendation includes a note: "These basic restrictions and reference levels for limiting exposure have been developed following a thorough review of all published scientific literature ... since there are safety factors of about 50 between the threshold value for acute effects and the basic restrictions, this Recommendation implicitly covers possible long-term effects in the whole frequency range."
